Preamble

This report addresses the requirements for measuring child maltreatment in care statistics, in compliance with the Stipulated Third Remedial Order, provision 7.a.1 and 7.a.2. Provision included below:

7.a.1 Public Catalyst will certify the baseline for maltreatment in care of children who are in the custody of MDCPS.

7.a.2 The rate of maltreatment in care shall be calculated as follows: Of all children in foster care during the period, what percent were victims of substantiated maltreatment by a foster parent or facility staff member. A child is counted as having been maltreated in foster care if the perpetrator of the maltreatment was identified as a foster parent or a residential facility staff member. The numerator shall consist of all children whose maltreatment is substantiated during the period. The denominator shall consist of all children placed in foster care during the period. The observation period is six (6) months. The initial reporting period for this indicator will be April 1, 2016-September 30, 2016.

This report covers the period from 2016-04-01 to 2017-03-31.

In the tables below, *Total Children Served* indicates the total number of children who experienced more than one day in foster care during the period in the region indicated, *Total Substantiated* indicates the number of those children who were found to be the victim of maltreatment during their stay in foster care as perpetrated by a foster parent (relative or non-relative) or facility staff member, and *Maltreatment in Care Rate* is calculated as described in STRO 7.a.2

A finding is attributed to a child in the reporting population if the incident for which the finding was generated occurred in a custody episode that overlaps the reporting period.

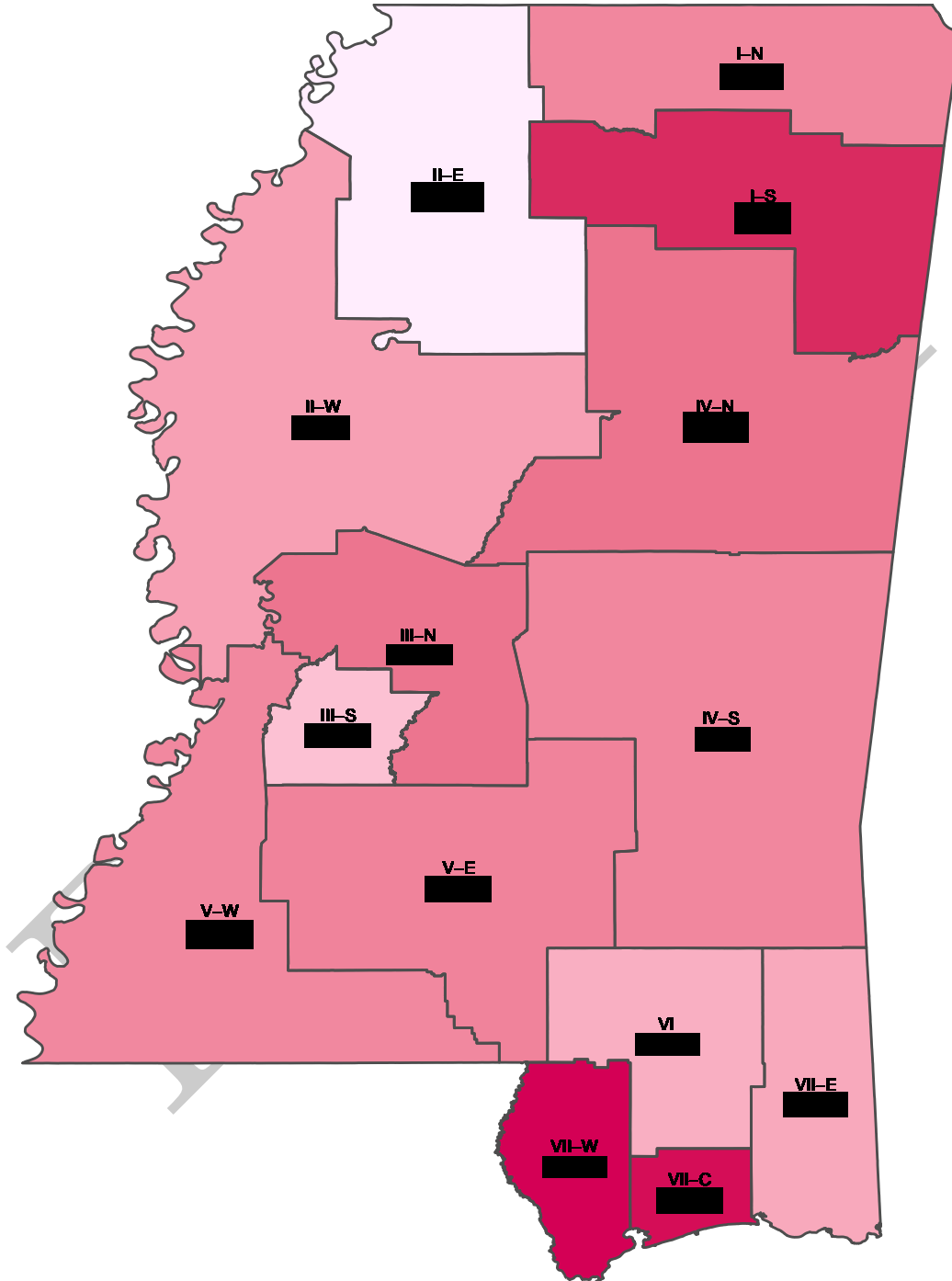

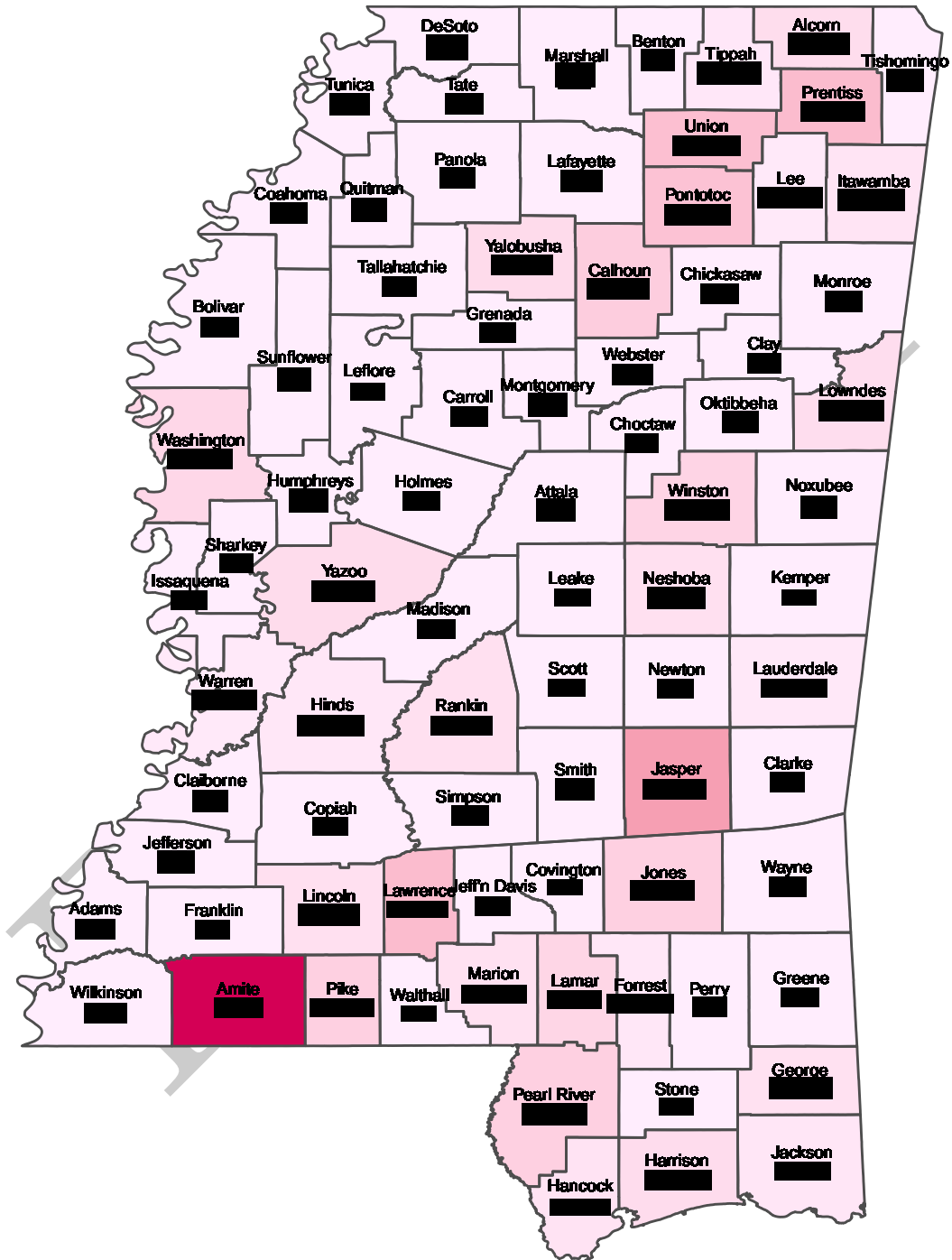
